

Report of Scoping Visit in Rajasthan

1. Objective of the scoping Visit:

Under the project scoping visits were made of all the four states of Assam, Karnataka, Odisha and Rajasthan in the month of October, 2013. These visits were meant for finalizing the State Level Partner Organisation and to share about the project to enhance SLPOs understanding, knowledge about the overall project idea, objectives, goals, key features and activities along with methodologies, strategies and approaches, target groups, government departments and agencies etc. During this visit state partners were also sensitized about the Rural Non-Farm Sector as a whole and the key activities of Research, networking and advocacy part along with the web portal and its interactivity.

Scoping visits also meant for meeting with the key government department officials like Rural Development Department, State Rural Livelihood Missions, National Institute of Rural Development, State Institute of Rural Development, NABARD, major research institutes of the state working in the area of livelihoods to brief them about the project and seeking their active cooperation throughout the project period.

During the scoping visits major NGOs which are working in the sector of Livelihoods or RNFS were also targeted to meet their management officials for briefing them about the project and their active cooperation.
